We are happy to greet all of our new and returning students. We, the Good Counsel Learning Center staff, are eager to work with each and every student in making progress. This is an exciting challenge.

LOCATION

The Learning Center is housed in the North and South basement corridors of St. Joseph Hall. Our space has expanded to most of this floor. The entrance is located on the Theresa Hall building which reads "Learning Center." Come in and go down the stairs. The Learning Center door is open from 3:00 p.m. until 5:00 p.m.; otherwise please use the main entrance. At the main entrance go up the stairs to the reception desk. Do not go down the stairs to the conference area.

Tutors will be there to meet you and take the students to their assigned room.

Students may leave the Learning Center through the door on the Theresa Hall building which reads "Learning Center." The students may also be picked up at the main entrance.

There is a **SITTING AREA** in the middle passage. You may also use the lounge room near the library.

The **BATHROOMS** ARE UNISEX. There is one located in the North and South ends of the floor.

The **OFFICE** is located in the South corridor.

CLASS ATTENDANCE

It is very important for students to be on time and to attend classes regularly. We request that you contact us if your child will be absent or late for class. Tutors need this information as early as possible. They spend much time preparing and it is unfair to wait for students who will not attend. We do charge for unexcused class hours.

Students who miss four (4) unexcused classes will be discontinued.

is to work with students on a one-to-one basis, helping them improve their skills which will enable them to be successful in life.
