Planned Giving Options



Join the SSNDs in transforming the world through education with a legacy gift to support SSND ministries and to help meet the retirement needs of sisters. Planned giving may be made through the following options:

Bequest from your Will/Living Trust

You can easily make a charitable gift of a specific dollar amount, percentage of your estate/trust, a certain asset or make the School Sisters of Notre Dame a “residual beneficiary.”

Retirement Plans

The School Sisters of Notre Dame can be named as a beneficiary of your pension, 401K, IRA or other retirement plan.

Securities, Stocks and Bonds

The School Sisters of Notre Dame welcome gifts of publicly traded securities, stocks or bonds.

Life Insurance

You can name the School Sisters of Notre Dame as full or partial beneficiary on life insurance policies you carry.

Real Estate
